


SAND LAKE BUILDING, A CONDOMINIUM SECOND FLOOR COMMON ELEMENT DESIGNATION







SAND LAKE BUILDING, A CONDOMINIUM COMMON ELEMENT DETAIL FIRST FLOOR








SAND LAKE BUILDING, A CONDOMINIUM COMMON ELEMENT DETAIL SECOND FLOOR
















SAND LAKE BUILDING, A CONDOMINIUM

FLOOR PLAN UNIT #1-3




